#### **Overview**

- Background The New Mexico Health Insurance Exchange (NMHIX) has elected to move from the Federally Facilitated Exchange (FFE) for individuals to a State Based Exchange (SBE), which means enrollments will come from NMHIX as opposed to the FFE
- Premium Remittance The most prominent change to carriers in this project is that the exchange will bill and collect premium payments for coverage. The exchange will aggregate that premium to each carrier monthly and report it in the EDI 820 format. This presentation discusses the 820 companion guide we have created for this purpose.

# **Background**

NMHIX has engaged Optum and NFP Health to build, deploy and operate a State Based Exchange for individuals beginning with policy year 2022. The Exchange will include eligibility determination, enrollment and billing, payment collection, and integration with carriers.

Today's topic will focus on the 820 EDI payment file that will be sent from NMHIX to the carriers.

- New Mexico Individual Exchange Companion Guide will be provided at the conclusion of this meeting
- The premium collection, aggregation and delivery to carriers via the 820 will streamline enrollment and billing reconciliation. For example, carriers will receive EDI add transactions for enrollments for which groups have already paid.



#### **Remittance Process**

- Members will be making payments to the exchange for their January 2022 coverage beginning November 1, 2021. Members will continue to make payments to their carrier for coverage months prior to 2022
- Payments will be applied to unpaid coverage months oldest to newest
- Applied payments will be aggregated once per month
  - NMHIX will wire a single ACH payment to each carrier
  - EDI 820 will itemize payments at the policy coverage month level
- The 820/834 discrepancy process will be discussed at the 9/30 Reconciliation meeting



### **Payment Example**

- Subscriber enrolls as a single subscriber into a single plan
- Payment is made (PAY) for March 2021 coverage and remitted to carrier

#### **Adjustment Example**

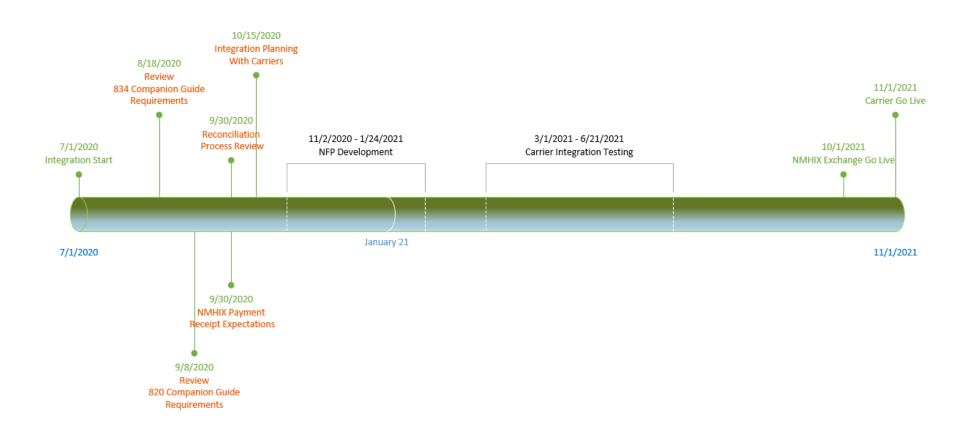
 Subscriber gets married, which adjusted the March 2021 premium retroactively. This results in adjustment for March coverage (ADJ) to offset the previous payment, followed by a new payment (PAY) that was made for the new coverage.
