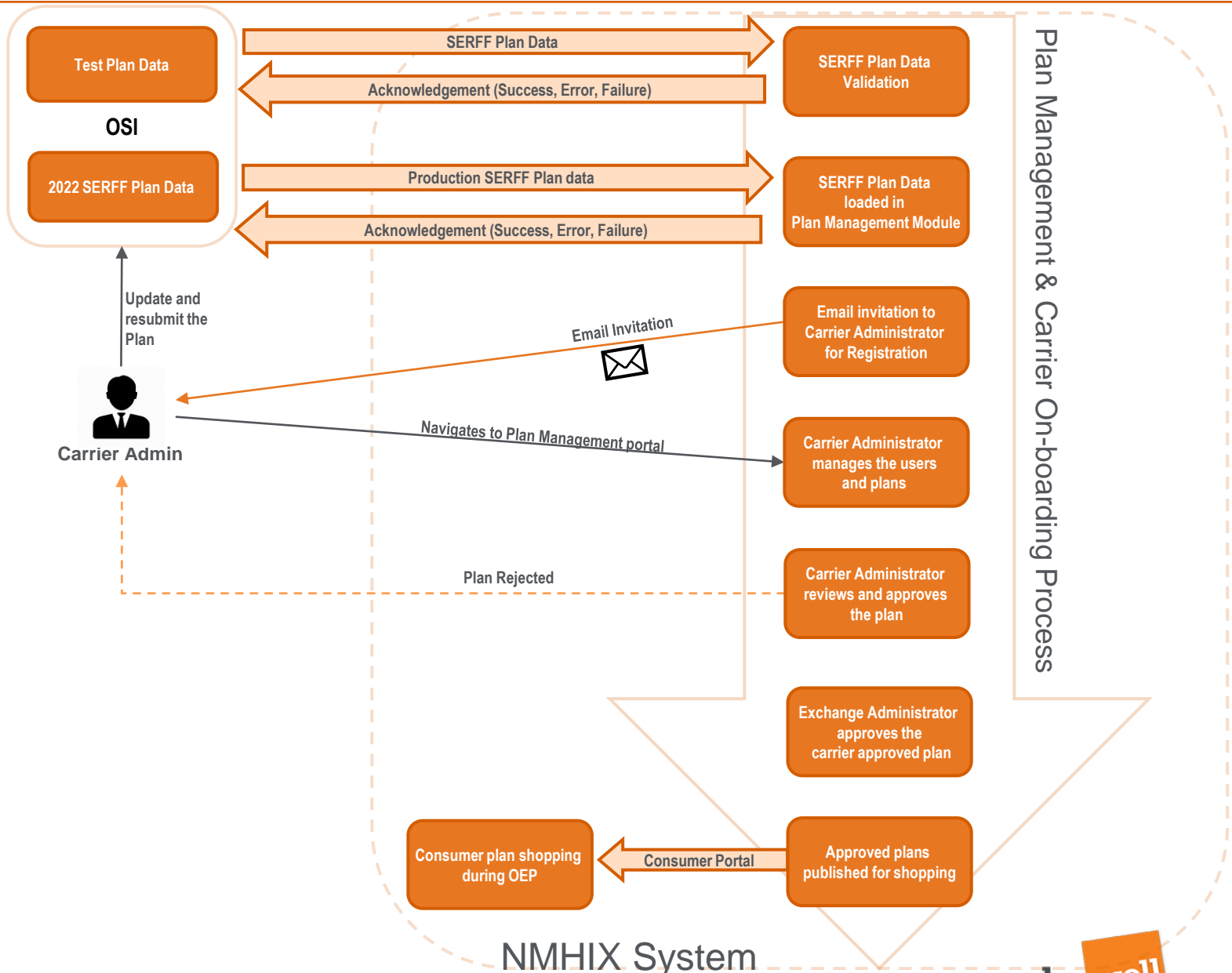

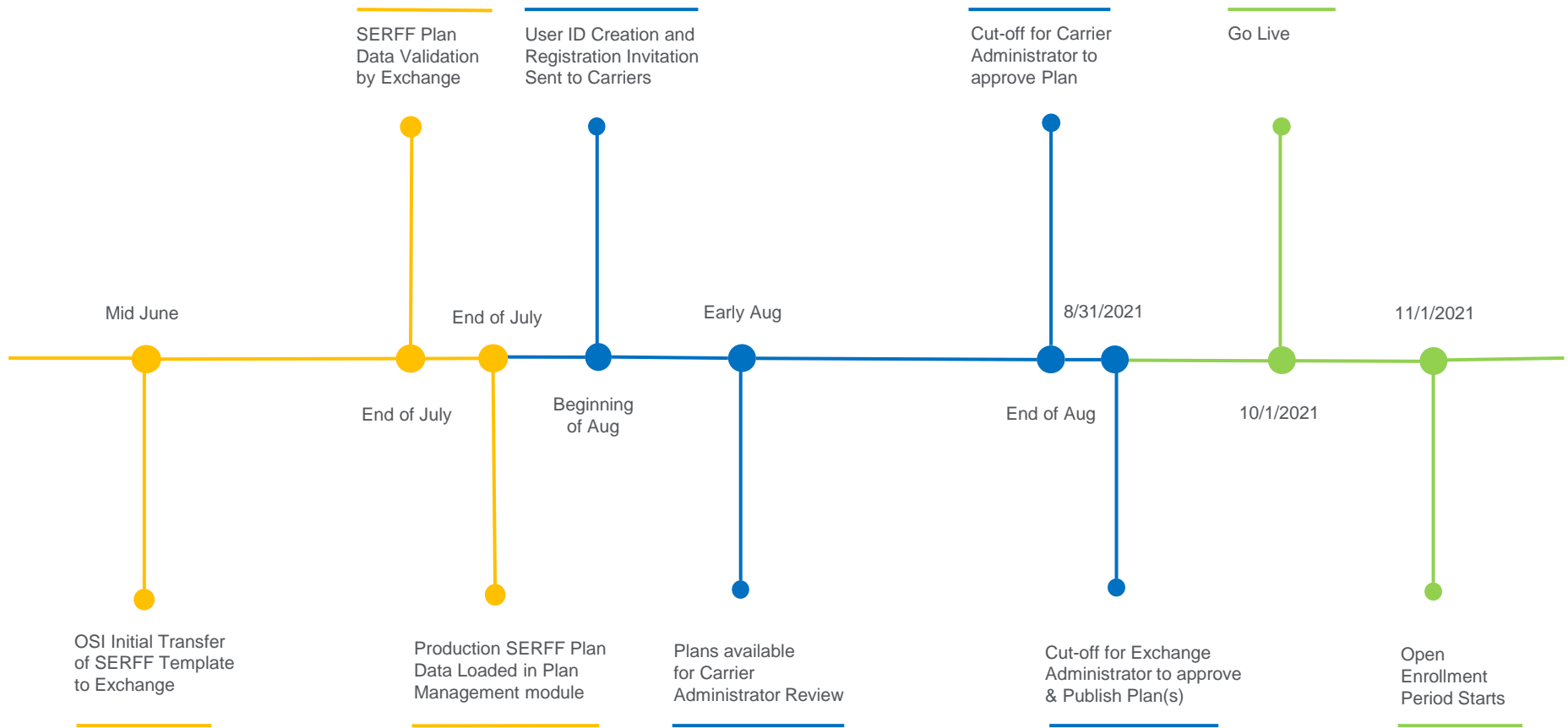
Executive Summary

- ❑ As New Mexico is transitioning to an SBE for 2022 plan year, carriers will need a platform where they can check their plan, rate and benefit information before it is published and made available to consumers for shopping on the beWellnm exchange.
- ❑ The Plan Management Module will be used by the Carriers and Exchange administrators as a platform to review the SERFF plan data and provide approval to push the plan data to the production environment.
- ❑ The Plan Management Module involves coordination with several entities to support the SERFF plan data review and approval processes:
 - Carriers
 - OSI
 - NMHIX
